1. Camp Shamineau Retreat Centers

Relax in one of the retreat centers with individual rooms, sharing restrooms within the buildings. Beds are single bunk beds. All buildings are a short walk from all activities.

2. Camp Shamineau Campground

The campground can accommodate tents, campers, and motor homes, with all sites offering electric and water hookup. Picnic tables and fire rings are available, and firewood is provided.

3. Camp Fire Bay Resort: 31504 Azure Road, Cushing, MN 56443,

The resort is located just east of Hwy.10 on Fish Trap Lake about 4 miles south of Camp Shamineau. The resort is on level ground, with no roads to cross or hills to climb. Lodging will be charged by the bedroom not by the person. Cost is \$70 per bedroom per night in new, completely furnished cabins. **Please do not call Camp Fire Bay to make lodging reservations.** Just complete the ENCORE Retreat Registration Form, marking interest in more information on Camp Fire Bay. Send in the amount due for the meals, snacks, and activities to Camp Shamineau. Information about Camp Fire Bay will be sent to you.
